ADMISSION NOTIFICATION Academic year 2019-20

A two-year full-time MBA program in Pharma-biotechnology i.e. MBA (Pharma-Biotechnology) (MBA-PBT) has been introduced in the Pune University, from the academic year 2015-16, with an intake of 60 students each year.

Qualifying Exam and Eligibility:

- Qualifying Exam: ATMA Entrance Exam conducted on December 23, 2018, February 17, 2019, or May 26, 2019.
- 2. Eligibility: A candidate who has either passed with minimum 50% of marks in aggregate (45% in case of reserved category candidates from Maharashtra State only) or appeared at the final year examination in any Bachelor's or Master's degree in Sciences (general or special with Biology, Biochemistry, Biotechnology, Botany, Chemistry, Environmental Sciences, Genetics, Life Sciences, Marine Biology, Microbiology, Physics, Zoology etc), Agriculture, Ayurveda, Medicine, Engineering, Pharmacy, Technology, Veterinary Sciences, Technology Engineering from a university recognized by the Association of Indian University (AIU) would be treated as eligible.

In addition the students <u>need to qualify</u> in the entrance examination, ATMA test (See details at http://atmaaims.com/) as part of admission procedure.

<u>Note</u>: The term 'aggregate marks' used here means the grand total of marks obtained by the candidate, taken together for all the subjects, based on which the class declaration is made by the University. However, the candidate would be treated as eligible for admission to MBA (Pharma-Biotechnology) program for the academic year 2019-20 ONLY IF he/she passes his/her graduation on or before 30th September 2019.

Minimum Marks Required: Open Category Candidates: 50% in Graduation

Reserved Category Candidates: 45% in Graduation

Batch Intake: 60 Students

Reservation:

- Reservation in admission of students to various Post-Graduate/Graduate/Integrated/ Interdisciplinary courses shall be as per the norms laid down by the Government of Maharashtra from time to time including reservation for the person with disabilities/Orphan and Defence Personnel's Child/Ex-Serviceman Child.
- 30% seats are reserved for female candidates for Under Graduate courses as per Government of Maharashtra Rules.
- Reservation for SBC category as per Government of Maharashtra rules.

Supernumerary Quota:

- Supernumerary quota for admission to Post-Graduate/ Graduate/ Integrated/ Interdisciplinary courses shall be as per the provision of Ordinance 181-A amended, University Order. (Circular No. PGS/1224/25 dated 12/04/2019).
- In case of candidates who want to seek admission under supernumerary quota, it is necessary to submit appropriate documents at the time of admission.

Fees and Mode of Payment:

• Following fee is applicable :

a) For candidates belonging to General category : Rs. 500/b) For candidates belonging to Reserved categories : Rs. 350/-

Payment should be made online using Debit/Credit Card/Net Banking etc.

Instructions for Filling Online Application:

- Online application form is available on the website: https://campus.unipune.ac.in/ccep/login.aspx
- Required Documents: Candidate shall upload the following documents with the application:
 - a) ATMA score card
 - b) Photo-copy of the statement of marks of the qualifying examination passed, if applicable (which is required for the eligibility.)
 - c) Photo-copy of the caste certificate in case of Reserved category candidates (if applicable).
 - d) Photo-copy of the Non-creamy layer certificate in case of Reserved category (OBC/DTNT/SBC/EWS/SEBC/Women) candidates (if applicable).
 - e) Photo copy of the Medical certificate issued by the Civil Surgeon in case of 'Persons with disabilities (P.H.)' candidates (if applicable).
- Candidates are NOT required to submit printout of application/documents to the University after online submission of application. However, these documents in original have to be submitted to the respective Department at the time of admission.
- Incomplete applications/ applications without uploading required documents/ applications submitted after the last date will be rejected without assigning any reason and no correspondence will be entertained by the University in this regard.
- No request for change in any information provided in the online form will be entertained by the University.

General Instructions:

- In case of any grievance of disputes the decision of the admission committee shall be final and binding on all.
- Admission to any program does not guarantee Hostel facility or any kind of financial support in any form like Scholarship, fellowship, Earn & Learn etc. The University has independent procedure for offering such benefits.
- Various scholarships by Government(s) shall be admissible as per prescribed rules in this regards.
- It is the responsibility of the applicant to fulfil the eligibility conditions and comply with the admission requirements. If at any stage it is notice that a falls claim has been made by the candidate or important material facts have been concealed and / or the candidate is not eligible, his candidature shall be liable for cancellation at any stage.
