Selected candidates are required to confirm their admission at the Department of Management Sciences (PUMBA) by completing the Online Admission Process (by Registering, Uploading copies of all their original documents and by paying the requisite fees) from **Monday 11th to Friday 15th January 2020**, failing which the seat will be offered to the candidates in the next round.

Procedure for Completion of Admission is as follows :

Step 1 – Selected candidates will receive a link from 'One Campus Portal of SPPU' on the email-Id mentioned in their application.

Step 2 – Use the link for filling up the Admission Form (Profile Information and Uploading all the necessary documents (PDF format) as per the list given below). Submit the completed form by clicking on the button 'Send to Department Approval'.

Step 3 – The department will approve the candidate for admission online after scrutinising the details. The Fees Payment link on the One Campus Portal will be then activated.

Step 4 – Candidate will log-in the portal to make the payment of fees by **ONLINE** payment mode (through NET Banking, Credit Card OR Debit Card ONLY - Please check the limit of your Card, as it has to be done through Single Card only)

Step 5 – Download the Admission Form and Fees Payment Receipt. Submit the softcopies (PDF) of these documents to our office by an e-mail to : Mrs. Mumtaj Shaikh (mumtajshaikh76@gmail.com) with a cc to Dr. Ranjeet Chitale (rhchitale@yahoo.com) to Complete the Process.
